Guest An individual who is legally admitted to the campground and identified on the Seasonal Site Agreement. Guests are permitted to stay on the Campground overnight and are subject to additional seasonal fees.

Visitor A Visitor is defined as a non-seasonal guest, or person(s) staying for the day only. Visitors are subject to a day fee for use of the premises. Visitors are not permitted to bring any pets onto the premises.

Campground The Camp-Resort / Park is referred to as "Campground" in this Handbook.

Management Refers to campground Management. Often this may include, but is not limited to, the General Manager or other Department Managers of the Campground.

Section I

General Seasonal Camping Information

- Club Yogi Rewards: Provide your CYR number to the park office. With each in-store
 purchase charged to site, you receive points towards camping discounts, online raffles or
 contests. For more information, visit www.jellystonerewards.com. Seasonal campers receive a
 flat 500 points for their stay.
- 2. **Communications:** The primary method of communication is email. If you do not provide an email address on your Admission Agreement, you are opting out of prompt notifications from the park office. The park will no longer use postal service mail for notices, invoices, or receipts.

- 4. Lost and found: Located in park office.
- 5. Mail/Packages: The park cannot accept responsibility for your packages or mail: these will be REFUSED at time of delivery. Please obtain a mailbox at eh post office in Uniontown or Hartville. Located 861 W Maple St, Hartville, oh 44632 or 11230 Cleveland Ave NW, Uniontown, OH 44685 Packages from UPS Or FED EX may be held for pickup at the UPS store or FED EX office. Campers and registered guests are not tenants and may not claim the park's address as a residence.
- 6. **Site Boundaries:** Most boundaries are from the electric pedestal to the electrical pedestal. IN most cases, this is exact unless the electrical connection for your site is in unusual place. Try to keep the "spread" of your items on the tail end and awning side of RV/Camping Unit. Ask the office for more details about specific site boundaries.

Section II

Financial Obligations & Policies

- 1. **Early Termination:** Akron/Canton Jellystone Park TM does not issue refunds for early termination of your Seasonal Agreement. Management must be notified before removal if you wish to end this agreement early.
- 2. **Electric Meter and site Charge Billing:** Electric is charged at a rate of \$0.20 per KW/HR Electric Meters are read at the beginning of each month Payments are processed automatically by the office from the credit card on file. This change will usually occur the first Friday of each month, however, it may occur on the second Friday depending on when meters are read. An invoice will be emailed out prior to this automatic charge. Any site/utility charges must be paid in full every billing period. Failure to pay balances in full each month will result in suspension of site charges for the rest of the season, a \$25.00 / week late fee and a forfeit of site for the 2026 season. The park reserves the right to end any seasonal agreement early WITHOUT REFUND if an unreasonably high balance increases without intent or ability to pay in full on time. End of season billings will be emailed by October 26th and due by October 31st. Balances may not be carried over into the 2025 season.
- 3. **2024 Amendment: Charge** to site is a payment possibility available at all point-of-sale locations within the park. Campers may provide their site number and last name at check out for quick and easy payment. Site charges are solely meant to be a convenience, not to be used as loan or line of credit that is paid down as you are able. It is in your best interest to never charge something to your site that wouldn't clear the card on file at time of purchase. While we traditionally charge cards weekly or monthly electric bill, **the card on file is subject to billing of all site charges added without notice at any time**. Request to make installments on site balance or delay payment on monthly bill will only be accommodated for extenuation circumstances and will be subject to a late fee no less than \$35.00/ Week. A repeated inability to abide by our site charge policy will revoke any opportunity to renew your site at our park for future seasons.
- 4. **Mowing/Lawncare:** Site must be mowed and trimmed once per week. Flower beds and plantings are always to be maintained. Campers are responsible for providing their lawn care

- equipment; riding mowers/tractors cannot be used. Weekly mowing is available for \$20.00/week fee. Sign up at the office for this service. Sites that are not mowed once per week are subject to park staff mowing them and your account will be charged \$20.00 for each cut.
- 5. **Outside Storage:** Outside storage is available near the main parking lot, \$60.00 per month for seasonal campers only. Outdoor storage should be used if you need access to your RV/Camping unit between October 22nd, 2024, to May 3rd, 2025. The seasonal camping area is closed and not accessible. There will be a \$200.00 fee if you need a seasonal gate opened to remove your RV during the off-season.
- 6. **Site Payment:** A non-refundable down payment of \$350.00 is needed to secure your campsite on October 15th, 2024. This payment will be applied to your 2025 seasonal admission rate. Gate keys will not be issued until the site is paid for in full. There are no refunds for the site once any fee is paid. **A \$200.00** increase will be applied to the new 2025 camping season.
- 6 **Site Payment Amendment:** A fee of \$25.00/ week will be applied to any open balances after March 1st, 2025.
- Payment Types: Down Payments may be made with cash, check, or credit cards. Checks must be made payable to Akron Canton Jellystone or Clearwater Park. The balance of your seasonal site fees may be paid with cash or Check. A 3% surcharge applies to credit card payments on the remaining balance. Exact payments dates will be announced at the end of each season.
- 8 **Refunds/Transfer:** Season camping admission fees are non-refundable should you choose to leave earlier than October 22, 2025. Should you sell your camping unit during the season, the new owner has the choice to sign a Seasonal Camping Admissions Agreement and use the site. Please see "Sale of RV/Camping Unit" for more information.
- PReturning Next Season: if your agreement is extended to return for the 2026 Season, we must have your signed Agreement and non-refundable down payment of \$350.00 by October 15th, 2025. This Amount is applied towards you 2026 Seasonal Camping Admission Rate. If you are leaving your RV/Camping unit on your site for the winter, A \$200.00 storage payment is due by October 15th, 2025. An invoice for the remaining 2025 season balance will be sent by October 31st, 2025. If you are not returning for the next season, your RV/Camping unit and all other items must be removed from your site by 5:00pm on October 20th, 2025. Winter parking is available to only those sites returning for the 2026 season. Campers who have not returned their signed Seasonal Camping Admission Agreement and down payment by the deadline will lose their site. The forfeited site will then be made available to another prospective guest of the park. Out of Agreement, campers will be charged \$100.00 per 30 days of storage. Reasonable attempts shall be made by Jellystone to contact the Owner/ Camper and collect fees due. Any camper who are out of Agreement for a period of 60 days or more shall have their property remaining on the

- campsite abandoned. The abandoned property is subject towing and/ or disposal by Jellystone without further notice.
- 10 **Season Opening:** The Seasonal Campground opens May 9th, 2025. Campers with outstanding balance will not have access to site/gate access or electricity.
- 11 **Season Closing:** October 26th, 2025, at 5:00pm. Plan to winterize before this date. The final electric bill will be sent via email on October 26th and is due by October 31st. 2025. Non returning guests, please have your RV/Camping unit and all personal items off the site by October 26th, 2025, by 5:00pm. Any RV/Camping unit not removed are subject to a monthly parking fee of \$100.00/30 days. After 30 days, all items still on the campsite will be considered abandoned. The abandoned property is subject to towing or disposal by campground without further notice. The storage fee is not pro-rated.
- 12 **Security Deposit:** A refundable Security deposit of \$200.00 is needed for any seasonal camper not established before October 1st, 2017. This deposit is in addition to the \$350.00 down payment and does not apply to your balance on site fees. The deposit will be refunded at the end of your stay provided you return the campsite to the same condition as when you first occupied the site. All items (personal possessions, trash, wood, debris, steps, decking, sheds, and the like) left on your campsite will lose the \$200.00 deposit.
- 13 **Sewer Policy:** Improper sewage disposal will not be tolerated and is subject to an immediate \$200.00 fee and ejection from the park without refund.
- 14 **Substitutions**: Substituting any campers listed on your Agreement is strictly prohibited, all names placed on your list at the beginning of the season is final.
- 15 **Vacating your Site:** you are not allowed to remove your RV/Camping unit from Akron/Canton Jellystone Park TM without first notifying the park office. Outstanding balances must be paid in full. As a Season Camper, you agree to pay your balance and any attorney fees for court cost (if applicable).
- 16 **Winter Parking:** If you intend to leave your camper on your campsite over the winter the fee is \$200.00. The down payment parking fee of \$100.00 along with a \$350.00 non-refundable down payment for the site are due not later than September 15th, 2025. There will be no access to your camper during the winter season. If access is needed November-May, there will be a \$200.00 charge to open the gate. Contact the office for more details on Winter Parking.

Section III

Access to the Campground

1. **Activities:** You and your registered family members are encouraged to take part in activities and crafts planned by the activities staff. Some projects and crafts may incur extra costs pg. 6 Yogi Bear's Akron-Canton Jellystone Park TM12712 Hoover Ave., Nw. Uniontown OH 44685

associated with them. Supplies may be bought at the activity barn with cash, credit card, or by using your account site charge. Weekly activity schedules are available on CampersApp and on print outs available at the park office. An adult must always go with Children under 13. Please do not drop them off at Rec center. Any children that are continual distractions to the activity staff because of their actions, attitude, misbehavior, or lack of regard for the safety of themselves or others will be asked to leave the Rec Center area.

- 2. **Background Check Authorization:** Akron/Canton Jellystone Park TM is committed to providing a safe, family-friendly environment for its campers. Thus, all adults, ages 18+ applying for seasonal campsites must consent to a criminal background check to be considered for admission to Akron/Canton Jellystone Park TM.
- 3. **Day Use Visitors:** You and your children may have friends over to stay the day. They must register at the office as a visitor to gain access to the facilities. Visitors wanting to use amenities will receive a wristband for \$15.00/person. Dinner guests are free for season guests. After 10pm visitors on the premises and all unregistered visitors will be considered trespassers and will have to leave.
- 4. **Day Use Parking:** Daytime visitors are welcome to park at your campsite if space is available. They must be entirely off the road and not hanging over onto another campsite or parked in an empty campsite. If there is not enough space available at your site, your guests can park across the street in the main parking lot by the pool.
- 5. **Gate Key:** Two tap-style gate keys will be issued to each seasonal campsite. All gate keys must be returned at the end of camping season. A \$20.00 charge will be applied per key to replace any lost gate keys.
- 6. **Gates Access:** Your gate keys are registered to you, if you lift the gate for someone unauthorized to be inside park you risk getting evited with no refunds.
- 7. **Mini Golf:** The mini golf is available to you and your registered site user any time the course is open for business. Please provide your seasonal identification when playing.
- 8. **Visitors:** All Visitors intending to use the park amenities must register at the office. Visitors will be given a wristband that is food for the number of nights they are staying. \$15.00/person per night. You are responsible for their behavior and any damage they may cause.
- 9. **Season Opening:** May 9th @12:00pm.
- 10. **Season Closing:** October 26th @ 5:00pm.
- 11. **Seasonal Identification:** Each registered seasonal camper will be issued a form of identification. Your seasonal identification is needed for participation in activities, min golf, and entry into the pool gate. Seasonal identification remains the property of Akron/Canton Jellystone Park TM and must be surrendered upon the request of the park management.

- 12. **Speed Limit:** 5MPH park wide. (including golf carts)
- 13. **Waterpark/Pool:** You must present your seasonal identifications at the water park entrance each time you gain entry. We are not able to open the water park if there are not enough staff, ongoing maintenance, or weather-related issues. Please Park in the pool parking area across the street from the main gate. An adult must always go with children under 13, do not drop them off. Any Children that are a continual distraction to the lifeguards because of their actions, attitude, misbehavior, or lack of regard for the safety of themselves for others will be asked to leave. Should the behavior continue, they will lose all privileges at the park for the rest of the season. These rules also apply to friends and visitors of registered seasonal guests. The pool reserves the right to adjust food and drink policy throughout the season.
- 14. **Winter Access:** After October 26th, 2025, the seasonal area is closed. There is no access between October 25st, 2025, and May 2nd, 2026. A \$200.00 fee to open the gate in the off season.

Section IV

General Camping Policies

- **1.Alcohol:** Alcohol is allowed but must be stored and consumed at your campsite. No consumption or open containers off your campsite. No open containers or consumption while operating a motor vehicle, including golf carts.
- 2. **Bathrooms:** Open 24 hrs. unless posted otherwise for cleaning or maintenance. Please go with children under eight years old. Contact the office if bathrooms need attention.
- 3. **Campfire:** *NO OUTSIDE FIREWOOD IS PERMITTED.* Firewood is sold at the camp office by bundle as well as bulk orders. Please use a fire ring for your fire. Never leave a campfire unattended. Do not burn pallets, trash, rubbish, leaves, building materials, or any other items that are not firewood. Do not place ashes into the dumpster or roads.
- 4. Firewood: **NO OUTSIDE FIREWOOD IS PERMITTED.** We sell wood in bundles as well as in bulk at the park office. Do not stack firewood against trees. Up To one full



truckload of wood may be kept at your site.

5. **Campsite:** You must keep a clean and orderly campsite. No PALLETS are allowed for any reason. If you need to store items at your site, please see shed policy 3.25 for the proper size and style. You may not store items (deck, tarps, bikes, and the like) under your RV/Camping unit. All personal property to be stored at your site must be contained inside an approved shed. Firewood is the only exception, up to a cord of wood may be stored outside in approved holder. Park management reserves the right to upkeep any campsite it deems necessary at the cost of \$30.00 per man hour.

6. Chainsaws: Chainsaws are prohibited.

Tree trimming must have approval from the park manager- unapproved trimming could result in fine from the park.

- 7. **Clotheslines:** Strictly prohibited for the safety and aesthetics of our park. Laundry facilities are found on the upper campground side.
- 8. **Concession Stand:** In season hours are 11:00am to 9:00pm, Memorial Day Labor Day. Pre- and Post-Season hours are subject to change without notice; Please contact the parking office.
- 9. **Decks/Enclosures:** Each site may have a deck no longer than the length of the RV/Camping unit and no wider than the awning attached. Decks may not be anchored into the ground. The decking must be removed upon leaving the park. Decks constructed after October 16th, 2017, must be built in sections, each section cannot exceed 4X8. Deck not in compliance with this will have 30 days to comply.

Update: Decks before October 16th, 2017, have been grandfather into agreements.

- 10. **Decorations:** Please keep decorations, signs, flags, and the like to a minimum. The use of nails and screws in trees is prohibited. Political signs and flags are prohibited.

- 11. **Firewood Pricing:** \$8.10 bundle, \$145.00 ½ truckload, \$295.00 full truckload; Subject to change due to supply chain changes.
- 12. **Internet:** A password will be provided at the beginning of the season. Wireless internet is not secure and is provided for your entertainment. Some areas of the park will have better connections than others due to the geography of the park. Remember that bandwidth is limited and shared throughout the park. Park staff does not monitor the use of the public access internet. Guests accept all risks by using open-access internet.
- 13. **Landscaping:** You are welcome to landscape your site, but keep in mind that you're responsible for the upkeep of all flower beds and plants as well as mowing and trimming. If the campsite and flowerbeds become overgrown with weeds, dead leaves, or unsightly growth, the park reserves the right to clear the area out and plant grass seeds. All site improvements require pre-approval from the park manager, please see site improvements. Do not cut down or trim any trees, shrubs, or bushes without park approval.
- 14. **Laundry:** There is a coin operated laundry area found near the shower houses in the upper campground. There is a change machine found at the laundry facility or in the office during office hours. Please don't leave your items unattended in any machine. Any unattended laundry for period of 15mins will be moved out of machine by park staff.
- 15. **Leaf Removal:** Do not burn leaves. The park will provide a receptacle in the spring for the disposal of leaves. All sites must be spring-cleaned by the Thursday before Memorial Day Weekend.
- 16. **Parking:** you may park two vehicles at your site. If there is not enough room for your cards to park at our site, you will need to park in the parking lot across the street from the main entrance. The vehicles may not hang out into the road, or another site or be parked on an empty campsite. Do not park cargo trucks or semi-trucks in the camping area; use the lot across from the main entrance. While visiting the water park/pool, please park in the pool parking area. Please use designated golf cart parking where available.
- 17. **Pets:** no cats allowed. A maximum of two dogs per campsite. All dogs must be kept on a leash and under control; noisy or vicious animals are prohibited in parks. (breed restriction apply) Pets are not allowed in designated picnic areas or the camp buildings. It is your responsibility to clean up after your dogs. All seasonal campers with dogs must provide vaccinations record. Portable or permanent kennel areas may not be constructed on the campsite. Dogs may not be left unattended on the campsite. Excessive barking or aggressive behavior, failure to keep pet on leash or leaving your pet unattended will give the campground cause to require the pet to be removed from the park property. Upon two occurrences of the owner being required to remove pet the pet is no longer allowed to be on campground property.

- 18. **Playground:** There is a playground in the seasonal area next to the pavilion. A more extensive playground area can be found in the Family Fun Zone. Children must be supervised. Please do not use during quiet hours 11pm-8am
- 19. **Propane:** Propane is available for sale at the office. We fill portable tanks and motorhomes. Employees filling tanks reserve the right to deny filling any container that does not have a current certification, is rusty or they believe unsafe. Filling times may vary based on staffing. Bulk tanks and outside propane vendors are not allowed.
- 20. **Screen Room:** You are welcome to set up a free-standing screen room provided it is not attached to the RV/Camping unit or permanent in nature. Your campsite must have suitable space available. The maximum size is 10x10 built on enclosures and porches are not permitted.
- 21. **Sewer:** The Seasonal Camper is responsible for providing and installing the plumbing necessary to ensure supported, leak-free connection between their RV/Camping unit and the park-provided sewer connection using industry standards. AT NO TIME MAY A CAMPER DISCHARGE SEWER ON THE GROUND FOR ANY REASON. Improper sewage discharges are subject to added charges, and other remedies, up to and including immediate season camping agreements terminations with ejection from the park without refund.
- 22. **Shelter/Pavilion:** You are welcome to use the seasonal area pavilion for cookouts, at no added cost. Vehicles should stay at your campsite unless dropping items off or pick them up. Visitors must park in the lot across the street from the main gate. Loud or unruly behavior, use of coarse language, and music that is not family proper will not be tolerated. These are the reasons for canceling your event and removing your guest from the park. The shelter must be cleaned after each use; take the trash to the dumpster found in the overnight sections of the park.
- 23. **Site Improvements:** Improvements including but not limited to decks, patios, sheds, and the like. These sites alterations must be approved by park manager or owner prior to work beginning on your site. Unauthorized improvements are subject to added charges and remedies, up to and including immediate seasonal camping agreement terminations with ejection from the park *WITHOUT REFUND*.
- 24. **STORAGE SHED:** The park allows one 8x8 Rubbermaid style shed only. You are responsible for cleaning and free of overgrowth of vines, weeds, and moss.
- 25. **Tent:** WE do not allow tents to be pitched on your campsite.
- 26. **Trash:** Dumpsters are provided in the upper campground near the shower houses. Seasonal campers are responsible for the disposal of their own trash. All trash must be placed in a garbage bag. Any non-trash items, such as but not limited to carpeting, constructions materials, paints, furniture, old lawnmowers, or other bulky refuse is your responsibility to remove from the park. Please report overfilled dumpster to park staff, trash may not be placed outside the dumpster for any reason. A \$15.00 fee will be assessed to the site account for non-compliance.

27. **Washing Your Rv:** This is allowed, please conserve water usage. Please be aware that weekends are high water usage and washing of the RV should be kept to weekdays whenever possible. If using a pressure washer, please remember to recognize quiet hours and the possibility that noise or exhaust may be causing discomfort to your neighbor.

Section V

Conduct

- 1. Children: Parents are responsible for their children while in the park. All children must be accompanied by an adult for the ages up to seventeen. Do not leave children unattended at your campsite.
- 2. Drones: Due to the privacy and safety of our guests, we will not allow drones to be flown over the Akron/Canton Jellystone Park TM Any exceptions to this policy can be authorized only with the express written consent of Akron/Canton Jellystone Park TM
- 3. **Firearms/weapons:** Pursuant to the Ohio Revised Code. Unless otherwise authorized by law, no person shall knowingly possess, have under the person's control, convey, or attempt to convey a deadly weapon or dangerous ordnance onto Jellystone park premises.
- 4. **Fireworks:** All fireworks: sparklers and the like are prohibited.
- 5. **Quiet Hours 11pm-8Am**: This doesn't mean you need to go to bed. However, it does mean the park should be calm, quiet, not disrupted by loud voices, music, or bright lights, children running around unsupervised or other noisy activities.
- 6. **Police Presence:** upon two (2) visits by local law enforcement for non-compliance of local, state or federal laws or park policy, the park reserves the right to eject the Seasonal Camper(s) immediately and without any refund of any kind.

Section VI

Golf Carts & Vehicles

1. Bicycles: Bike riding after dark is allowed but requires that the bike be equipped with a headlight and taillight. Helmets must be worn. Please use bicycle racks where available – No parking by the office, please use bike racks at all times.

- 2. Golf Carts: Electric golf carts only in Jellystone Park. A Maximum of 2 golf carts per site. Proof of insurance for each covered driver is needed each season. NO DRIVER LICENSE- NO DRIVING OF ANY MOTORIZED VIHICLE AT ANY TIME. Golf carts driven after dark must have working headlights and taillights. Golf carts may not be used between the hours of 11pm-8am. Reckless driving, failure to still be on the roads, damage to property or not using proper parking areas will result in revocation of golf cart privileges. -Golf cart parking is prohibited by the office and firewood area. Always use golf cart parking. Handicap area is available per General Manager approval.
- **3. Golf cart OVI/Alcohol:** open containers of alcohol are not allowed on vehicles (golf carts included) per Ohio State Law.
- 4. Motorcycles: Motorcycles may be driven to and from our site but no around the park.
- 5. **Mopeds, scooters, ATV's and Minibikes** are prohibited. Unregistered vehicles and off-road recreational vehicles are not allowed.
- 6. RV or Camping Unit: An RV or Camping Unit refers to any Recreational Vehicle Industry Associations (RVIA) approved RV. Seasonal Campers must have an RV that is a maximum of 10 years old to be considered for acceptance. Your camping unit must be washed at least once per season to support a clean and moss/mold-free appearance. Your camping unit and other accessories (deck, screen porches, and the like) must be in good repair. Photos and proof of model year are needed with your application. Approval is at the discretion of management. Management reserves the right to not accept any RV/Camping unit that is not aesthetically cohesive to the Seasonal Campground.
- 7. Sale of RV/Camping Unit: if you sell your RV/Camping Unit, it must be no more than ten years old to still be in the park. Provided the new owner has completed the background check requirement, there's an option of signing a new Seasonal Camping Admission Agreement. Otherwise, the new owner must remove the RV/Camping unit within seven days of the sale. The original registered camper of the site where the sold RV/Camping unit is parked is solely responsible for removing all trash and debris from the campsite should the RV/Camping unit be removed. This includes, but is not limited to wood, metal, concrete blocks, shed, decks and carpet. Please get management approval before selling.
- 8. **Vehicles:** you are allowed for two automobiles to be parked on your site, provided they fit on site and do not hang over into the road or another campsite. DO NOT park on empty campsites, you will be fined. If there is not enough room for vehicles on your campsite, park at the main gate (pool area) across the street. Extra vehicles, boats, trailers, and the like may not be stored at your site.

Dog Park: Office must have copy of current vaccinations to use dog park.

Trees: are a natural beauty. Please do not harm the trees and vegetation at the Campground. Firewood is available at the office. Do not cut, mutilate, debark, drive nails, ax, or saw into dead or live trees. You may not hang anything from trees, including but not limited to clotheslines, rope lights, or cables.

Flags: The following flags are the only flags that are allowed to be displayed at your site and throughout the Campground: ● American ● Canadian ● Military (including Air Force, Army, Marine Corps, Navy, Coast Guard, POW, MIA, and veterans) ● Sports, and decorative flags such as holiday, seasonal, or garden
